

## **TERMS AND CONDITIONS – FRESH FOOD MARKET DAY GIFT WITH PURCHASE**

### **1 Introduction**

1.1 Participation in this Promotion and information regarding redemption of any Gifts forms part of these terms and conditions.

1.2 By submitting an entry into this Promotion, entrants warrant that they have read, understand and agree to be bound by these terms and conditions. If the entrant is under the age of 18 years, each entrant's consenting parent or guardian is responsible for ensuring their familiarity with these terms and conditions at the time of participation. Entry into this Promotion is deemed acceptance of these terms and conditions.

1.3 A copy of these terms and conditions can be obtained from Centre Management Office at Brimbank Shopping Centre.

### **2 Duration**

2.1 This Promotion runs from 11am to 2pm on Thursday 29 July 2021 or when the Gifts have been exhausted ("Promotional Period").

### **3 Eligibility**

3.1 This Promotion is only open to residents of Victoria.

3.2 Directors, officers, management, suppliers and their employees (and the Immediate Families of directors, officers, management, suppliers and employees) of the Promoter or of its related bodies corporate or agencies are ineligible to enter the Promotion.

3.3 If the participant is under the age of 18 years, the Gifts will be awarded to the winner's nominated parent or legal guardian.

### **4 Method of entry**

4.1 To enter, participants must:

(a) make a purchase of \$30 or more at the Participating Retailer during the Promotional Period; and (b) present proof of their purchase by presenting a receipt/s of \$30 or more spent at the Participating Retailer to the Fresh Food Market Station located in the Fresh Food Mall.

4.2 After presenting a receipt in accordance with clause 4.1, participants will immediately receive one Gift. Participants are entitled to one Gift per person during the Promotional Period.

4.3 Each receipt will be validated. All receipts must be clearly identified as being from the Participating Retailer and must carry a date being the date which is the same day and time as the day the receipts are presented to the Promoter.

4.4 The redemption of the Gift will take place at the Fresh Food Market Station between 11am and 2pm during the Promotional Period. The Promoter reserves the right to request winners to provide proof of identity and/or proof of entry validity in order to claim a Gift.
